#### Sample Bequest Intention Language

**NOTE:** Parishes and many Catholic schools and ministries have formal legal status under Church Law (Canon Law), but do not have independent status under the Civil Law of the Commonwealth of Massachusetts. The appropriate civil legal entity to receive bequests for Saint Cecilia Parish is the Roman Catholic Archbishop of Boston, a Corporation Sole, organized and existing in accordance with Chapter 506 of the Massachusetts Acts of 1897. Boston's Archbishop, Cardinal Seán O'Malley, OFM Cap, is charged by Canon Law with seeing that bequests to all entities related to the Archdiocese of Boston are handled to assure that the bequests of the deceased are fulfilled in all respects.

## 1 OUTRIGHT BEQUEST

#### a) Specific Dollar Amount

## 2 CONDITIONAL BEQUEST

## 3 **RESTRICTIONS**

## 4 FLEXIBILITY CLAUSE

"If, in the judgment of the Roman Catholic Archbishop of Boston, a Corporation Sole (the "Archdiocese"), it becomes impossible to accomplish the purposes of this gift, the income and/or principal may be used for such related purposes and in such manner as determined in the sole discretion of the Archdiocese."

## 5 LANGUAGE FOR HAVING MASSES CELEBRATED

#### a) Specific Number of Masses at a Particular Church

#### b) Annual Masses Over a period of Years

Otherwise, the parish will not receive the principal amount until all the requested Masses have been celebrated.
